#### Letter

A mentor of mine (Ben) once said, "Don't let the work you do *for* God destroy the work *of* God in you." He was specifically referring to being in ministry, but I think this principle applies beyond that. I believe that sometimes we can be so quick to *do* that we have forgotten how to *be*.

I believe we lean towards doing because it is so often concrete; it is tangible, measurable work. We like the feeling of accomplishment, of knowing that we've made a difference. And this sort of doing *is* important. Afterall, Jesus told us to go into the world and teach them everything he commanded. We are called to serve, to *do*. But Jesus also called us to abide. Jesus wants us to *be* with him.

We also know that this generation of students struggles with more anxiety, depression, and busyness than any generation in modern history. I (Amanda) see it often, and I know the importance of equipping students for these realities.

Why is this relevant to the mission trip for 2024? Well, West Side currently participates in a three-year rotation for its youth mission trips: year one is local, year two is national, year three is international. Each of these experiences is tied to *doing*, and the growth that happens from obedient serving. And we also take time to try and *be* as well.

In the fall, both of us (Ben from West Side and Amanda from Richland Lutheran) began to dream about a trip that would flip flop the above priority. What if we went on a trip that focused on *being* and took some time for *doing*? What if we added a fourth year into our rotation, so that a high school student who is in our program from freshman year would get four unique experiences?

This is what we are proposing for 2024. We want to take a trip that will help all of us, adults and students, grow closer to Jesus through experiences, conversations, quiet times, worship, and prayer. And because Jesus called us to both be and to do, we will spend one day doing service.

Therefore, after meeting with a team of high school leaders and adult leaders, we have determined that the mission trip for 2024 will be to Portland, OR and the surrounding area. We believe this location will give us some unique opportunities to bond to each other and to Jesus through fun, through nature, and through experiential learning.

So, thanks for being interested. Our hope is that through this experience, we'll all walk away better equipped to grow daily in our walk with Jesus, which will in turn help us to be better servants.

# COST TO FAMILY



# This year's regional trip will cost \$400. We are asking that you put down a \$50 deposit with the submission of this application.

With all of our trips, we seek balance between what is reasonable to ask of you as a family to pay and what we believe we can fundraise. Right now, we are asking that you be responsible for half of the cost (\$200) and the church will help cover the other half (\$200).

In years past, we have encouraged students to write letters of support to help raise the money. They can also mow lawns, babysit, etc. to help raise this money.

We will as a group be doing a fundraiser on Saturday, May 18<sup>th</sup> to help raise the church's half of the money. On top of that, people from church may choose to donate to an individual student (which would go towards the family's half of the cost) or to the trip as a whole (which would be applied to the other half of the cost).

#### COST

Any money that is raised for the mission trip that exceeds the overall cost of this trip will go towards future mission trips and projects. So, for example, if a student is responsible for paying \$200 but through donations and what the family pays, they actually bring in \$600, that \$400 dollar extra will not stay attached to that student for future trips, but rather be put in the pool that we would use to help pay for more expensive trips in the future. This actually helps us keep costs down for the more expensive trips in our rotation.

This application and a \$50 non-refundable\* deposit <u>MUST</u> be turned in by <u>Sunday, March 24<sup>th</sup>, 2024</u>.

#### Q: Who are the leaders of the group?

A: John Campbell (WS), Abby Grisham (WS), Ben Downey (WS), and Amanda Daniels (RLC)

#### Q: Where is the group staying?

A: We have found an Airbnb in Portland. It sleeps 16+ guests, has 6 bedrooms, 3.5 baths, 2 communal spaces, and some nice outdoor space as well.

#### Q: Will there be groups other than ours there?

A: No

#### Q: What kind of community service will be done.

A: As we're not focused on the community service for this trip, we would like for the students to help choose the project we do in or around Portland.

#### Q: Will I/my kids be safe?

A: Yes. While we will spend some time in Portland visiting some nature spaces to help us meditate and reflect, and will do some serving there, we don't plan to be there at night. In fact, we plan to spend much of our time at our Airbnb.

#### Q: What do I/my kids need to bring?

A: Please make sure you bring the following: bible, notebook & pen, weather & activity appropriate clothing for 5 days, weather & activity appropriate shoes, toiletries, sunscreen, & bug spray

# DISCIPLINE

#### DISCIPLINE PROCESS

The following is the discipline process to be implemented for behavior that does not call for the immediate action of sending the person home:

- 1. <u>Confrontation</u> after first offense.
  - The person will be given a chance to explain their behavior.
  - The behavior expectation will be explained to and repeated by the offender.
- 2. **Explanation** after the second offense
  - The person will be given a chance to explain their behavior.
  - The behavior expectation will be explained again and a consequence for a third offense will be determined and agreed upon.
  - This will be done in the presence of at least two leaders.
- 3. **Dispensation** of discipline after third offense
  - It will be relevant to the offense (as agreed upon in step two) and expeditious.
  - This will be done in the presence of the same two leaders.
- 4. Expulsion from the mission trip and sent home (at the individual's expense) The person who is unwilling to live according to the behavior expectations outlined in this document and is in open rebellion (exhibited by their unwillingness to submit to the deputation leadership) will be sent home at their own expense.

#### **IMMEDIATE EXPULSION**

Any person caught with drugs, drinking alcoholic beverages, stealing, or involved in fornication or adultery will be immediately sent home at their own expense.
